**CHILDBIRTH EDUCATION CONTRACT**

**Fee**

The cost of this course is \$150.00 and is due at the signing of this contract. As an option, you may split the fee into 2 payments of \$75.00 each, the first of which is due at the signing of this contract and the 2<sup>nd</sup> payment due at the beginning of the 2<sup>nd</sup> class.

**Refunds & Cancellations**

I require at least 24 hours’ notice for cancellations. In the event that less than 24 hours’ notice is given, a \$15.00 fee will apply. (This fee does not apply when severe weather conditions and/or last minute injuries are the cause of cancellation.) In the event of illness or injury on the part of the doula, severe weather or birth, the class will be rescheduled as soon as possible.

If you choose to cancel any remaining classes after the signing of this contract, the following will apply:

Cancellation after 1st class - \$50.00 of the total fee will be refunded.

Cancellation after 2nd class – \$25.00 of the total fee will be refunded.

(If your baby is born before you complete the course a refund will be issued for the missed classes.)
